





Background

The CeSRAC progress in 2020 has created a positive perception of CeSRAC as an Initiative to promote Science based principles, in FSSAI and the Alcohol Industry. With the COVID19 crisis impacting the industry, many planned events were transitioned to virtual mode.

The Master Trainer Program and the FBO training programs on Regulations in the Alcobev Industry

During the year, the Centre with active involvement of Senior official of the Food Safety and Standards Authority of India A(FSSAI) Standards Division, focussed on building capacity of Food Business Operators (FBOs) and Institutions associated in this sector in the area of Regulations for Alcoholic Beverages. In this regard it executed a cascading program which involved:

Training of the Trainer's (TOT) followed by FBO Training programs with FSSAI vetted Training content on regulations in Alcoholic Beverages sector during

the period of July- September 2020. The sessions were organized with Industry and FSSAI faculty involving Designated officers and Authorized officers of FSSAI helped promote an aligned interpretation of the Regulations and a comprehensive knowledge on the status of regulatory environment for this sector in India. More than 200 FBOs were covered through these programs. The training content developed under CeSRAC and vetted by FSSAI in May 2020 was utilized in all these virtual sessions.



1st CeSRAC Stakeholder E-forum

With a sustained focus on bringing in global practices on creating an ecosystem for Alcoholic beverage sector to facilitate Scientific developments, Regulations and Standards setting process, advanced testing & analytical methods, application of additives and processing aids and others in line with global standards, through a network of key scientific & standard setting bodies and National and International experts, the lst Stakeholder e- Forum of CeSRAC was organized in November on Leveraging Scientific Developments, Global Standards, Best Practices & Collaborations for Strengthening the Standards Setting Process for Alcoholic Beverages. It was attended by Regulators and FBOs of the sector.

The 1st CeSRAC Stakeholder E-forum had the CEO FSSAI Dr Arun Singhal deliver the keynote address. Dr Anu Appaiah chair of the FSSAI Scientific Panel on Alcobev along with international experts from OIV, SWRI, Spirits Europe, Diageo and Pernod Ricard deliberated on the key aspects related to Leveraging Scientific Developments, Global Standards, Best Practices & Collaborations for Strengthening the Standards Setting Process for Alcoholic Beverages
